Liability Waiver and Rental Agreement for Canoe Rental

By renting a canoe from Äventyr Kvill AB, the renter acknowledges and agrees to the following terms and conditions. This agreement must be signed before the start of the rental period, regardless of whether the booking is for individuals or groups.

There is no guidance during the tour.

1. Use at Your Own Risk

The use of the canoe (including all accessories such as paddles and life jackets) is at your own risk. The rental provider accepts no liability for accidents, injuries, or damage that may occur during use.

Each participant is responsible for their own behaviour. In group rentals, the person making the booking assumes responsibility for ensuring that all participants comply with the safety and usage rules.

2. Life Jacket Requirement / Children

- Wearing a life jacket is mandatory at all times while on the water – especially for children and non-swimmers.
- Children under the age of 12 may only participate if accompanied by a responsible adult.
- Supervisory responsibility lies with the legal guardians or accompanying adults.
- Canoeing is only permitted for persons who can swim.

3. Liability Disclaimer

The rental provider is not liable for:

- Loss, damage, or theft of personal belongings,
- Damage to electronic devices (e.g. phones, cameras) caused by water or environmental conditions,
- Health issues or injuries related to the use of the canoe or accessories,
- Damages to third parties, unless caused by intentional or grossly negligent actions of the rental provider.

4. Duty of Care / Rental Equipment

The renter agrees to:

- Handle the canoe and all rented items (paddles, life jackets, dry barrels, etc.) with care,
- Return all items on time, complete, and undamaged,
- Report any damage or loss immediately to the rental provider,
- Follow all safety instructions and applicable laws and regulations.

5. Alcohol / Drugs

Operating a canoe under the influence of alcohol, drugs, or medication is strictly prohibited. Violations will result in immediate exclusion from use without any refund.

6. Security Deposit

A security deposit of 2000SEK (200€) must be paid before the rental begins. The deposit will be refunded in full if all rented items are returned on time and undamaged. The rental provider reserves the right to withhold part or all of the deposit in case of damage or loss.

7. Insurance

The rental provider does not provide insurance coverage for renters. We strongly recommend having private accident and liability insurance.

8. Severability Clause

If any provision of this agreement is found to be invalid or unenforceable, the remaining provisions shall remain unaffected. Any invalid provision shall be replaced with a valid one that comes as close as possible to the intended purpose.
